

**AMENDMENT TO THE
PROGRAMMATIC AGREEMENT AMONG
THE FEDERAL HIGHWAY ADMINISTRATION,
THE SOUTH DAKOTA STATE HISTORIC PRESERVATION OFFICER,
THE ADVISORY COUNCIL ON HISTORIC PRESERVATION, AND
THE SOUTH DAKOTA DEPARTMENT OF TRANSPORTATION
REGARDING THE FEDERAL AID HIGHWAY PROGRAM IN SOUTH DAKOTA**

WHEREAS, the original Programmatic Agreement Among the Federal Highway Administration, The South Dakota State Historic Preservation Officer, The Advisory Council On Historic Preservation, and The South Dakota Department of Transportation Regarding the Federal Aid Highway Program In South Dakota (the Agreement) was executed on August 13, 2020, and is set to expire on August 13, 2025; and,

WHEREAS, FHWA, SHPO, ACHP, and SDDOT (Signatories) are in the process of renewing the Agreement; and,

WHEREAS, under Stipulation XII (A) the Signatories agree to amend the Agreement to extend its Duration in Stipulation XV; and,

NOW, THEREFORE, FHWA, SHPO, ACHP, and SDDOT agree that the SDDOT may continue use of the Agreement for implementation of the Federal Aid Program in South Dakota and Section 106 compliance.

1. Amend Stipulation XV so it reads as follows:

This Agreement shall be in effect until August 13, 2026, or until the execution of a new Agreement, whichever comes first. Prior to the expiration of this Agreement, FHWA, SHPO, ACHP, and SDDOT may consult to reconsider the terms of the Agreement and amend it in accordance with Stipulation XII, including to extend its duration.
