The Secretary's Corner

Social Media - Policy Reminders for Employee Usage

Below is an excerpt from the **BHRA Social Media Policy**, you can read the full policy at https://bhr.sd.gov/policies-forms/SocialMediaPolicy.pdf.



The State recognizes that the Internet provides unique opportunities to participate in interactive discussions and share information on topics using a wide variety of social media, such as Facebook, Twitter (X), etc. However, use of social media also presents certain risks and carries with it certain responsibilities. To minimize business and legal risks, to avoid loss of productivity and distraction from employees' job performance, and to ensure that the resources and communications systems of the State are used appropriately, the State expects its employees to adhere to procedures, guidelines, and rules regarding use of social media.

Compliance with Related Policies and Agreements: The same principles and guidelines found in the State's policies and employee handbook apply to employee activities online. Ultimately, employees are responsible for what they post online. Before creating online content, employees should consider the potential risks and rewards. Any employee conduct that adversely affects that employee's job performance, the performance of fellow employees, or otherwise adversely affects vendors, people who work on behalf of the State, or legitimate business interests of the State, may result in disciplinary action, up to and including termination.


Personal Use of Social Media: Employees should refrain from using social media during work hours or on State-owned equipment unless such use is work-related or authorized by the employee's supervisor and is consistent with the State's Technology Use Policy.

Be Respectful, Honest, and Accurate: Always be fair and courteous to fellow employees, vendors, or individuals who work on behalf of the State. The State expects the same level of professionalism and honesty in social media as it requires in all business communications.

<u>Do</u> use professional language	Don't post about your political views in a positive or negative way
<u>Do</u> be respectful and handle interactions with professionalism	Don't speak poorly of the SDDOT or other state agencies
<u>Do</u> disclaim that your views do not represent those of the State of South Dakota	Don't share information that you know to be inaccurate or false
Do remember your social media usage reflects upon the SDDOT	Don't discuss non-public information on either personal or professional accounts

SDDOT Safety News

The Labor Day holiday weekend is approaching and the U.S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA) is

working alongside your law enforcement community to decrease impaired driving. From August 13 through September 1, police departments across the nation will be participating in the <u>Drive Sober or Get Pulled</u>

Over enforcement period. The NHTSA wants drivers to understand the importance of planning ahead for a sober driver if alcohol is included in your Labor Day weekend plans.

Labor Day Statistics

- During the 2023 Labor Day holiday, there were 511 crash fatalities nationwide. Of those people, 185 (36%) were killed in crashes that involved at least one alcohol-impaired driver with a blood alcohol concentration (BAC) of .08 or above.
- In 2023, 30% of all traffic fatalities involved an alcohol-impaired driver. A BAC of .08 or higher is considered drunk driving in all 50 states, the District of Columbia and Puerto Rico, except in Utah where the BAC limit is .05.

The Cost of Drunk Driving

- On average, a DUI can set you back \$10,000 in attorney's fees, fines, court costs, lost time at work, higher insurance rates, and more.
- If you're caught drinking and driving, you can face jail time. Imagine trying to explain that to your supervisor, friends, and family.
- Drinking and driving can cause you to lose your driver's license and your vehicle. This could keep you from getting to work, resulting in lost wages and, potentially, job loss.

Celebrate with a Plan

Plan ahead if you will be celebrating the end of summer or over the long Labor Day holiday weekend. If you plan to drink, plan ahead for a sober driver to take you home. If it's your turn to be the designated driver, take the role seriously and don't consume alcohol, not even one drink. Always drive 100 percent sober. Even one alcoholic beverage could be one too many.

- Remember that it is never okay to drink and drive. Even if you only had one alcoholic beverage, designate a sober driver or plan to use public transportation or a ride service to get home safely.
- If you see a drunk driver on the road, contact your local law enforcement.
- Do you have a friend who is about to drink and drive? Take the keys away and make arrangements to get your friend home safely.

Recap 85th Annual Sturgis Motorcycle Rally: Aug. 1 - 10, 2025



Sturgis Rally Traffic Counts:

The SDDOT provided daily traffic counts at nine locations for vehicles entering Sturgis for the Rally. The daily counts are also posted to the <u>Rally Traveler Information page</u>. A complete 2025 Rally report is available on the SDDOT website at https://dot.sd.gov/transportation/highways/traffic-data/.



The 2025 Sturgis Rally 10-day total vehicle count was 537,459. This was an increase of 11.3% over the previous five-year average compiled from 2020-2024.

Primavera Tips/Tricks Consultants Utilizing Primavera "My Activities"

SDDOT utilizes **Oracle Primavera Cloud (OPC)** scheduling software to oversee its projects. Within OPC, there are "My Activities" licenses that enable resources to update their tasks. We are now extending these "My Activities" licenses to consultants, allowing them to update their activities.

Currently, only one person per consulting firm will receive a license, regardless of the number of active project work orders or assigned activities in Primavera. Consultants involved in preliminary engineering work orders will now have access to "My Activities," enabling them to update the status (e.g., Actual Start, Actual Finish) of their assigned tasks.

Project Delivery has created guidelines for assigning consultants in Primavera, ensuring they can access their designated activities. These instructions are available on the Project Delivery Intranet Page (https://intranetdot.sd.gov/projectdelivery.aspx).

One of the perks of being in the mentoring program is learning about different areas associated with the SDDOT that may be unfamiliar to some positions. The July Mentoring Event is a tradition that helps to broaden the horizons of SDDOT employees who may not otherwise have that opportunity. The July Mentoring Event was held in Rapid City and in Sioux Falls.

On July 22, 2025, 19 mentoring participants attended the event in Rapid City. The group toured the Rinker Materials facility, where various concrete products are made for highway construction, including pipe culverts, manholes, and prestressed concrete girders. Next, the group visited the U.S. Highway 385 grading project between Sheridan Lake and Pactola Reservoir. The final stop was GCC Dacotah, Inc., where cement is produced.

On July 29, 2025, 37 members of the group attended the event in Sioux Falls. Eggers Steel was the first tour of the day, where much of the structural steel is fabricated for highway and building projects across the Midwest and the Rocky Mountain regions. A tour of the new state-of-the-art Ace Redimix and Asphalt Plant was next on the list, followed by a few local projects in the Sioux Falls Area.

These events have proven to be one of the favorites of mentoring program participants, and this year did not disappoint. If you are considering enrolling in the mentoring program in the future, keep the July event in mind as one incentive to sign up!

SDDOT's Past Research Projects Now Available Online

SDDOT conducts research to improve the safety, efficiency, and cost-effectiveness of our transportation system. Over the years, these studies have covered a wide range of topics—from pavement performance and bridge materials to maintenance best practices and innovative traffic solutions.

Now, you can easily access the results of these projects online. The final reports for completed SDDOT research projects are available on the SDDOT website at:

https://dot.sd.gov/programs-services/programs/research/.

Simply click **Project Reports** and you'll find a list of completed projects. Each link will download a PDF version of the final report.

The reports are organized into four categories:

- 1. **Materials & Pavements** research on materials performance, pavement design, construction methods, and preservation strategies.
- 2. **Structures, Foundations & Drainage** studies on bridge design, foundation systems, drainage solutions, and structural performance.
- 3. **Operations & Safety** projects addressing traffic flow, safety improvements, roadway operations, and maintenance techniques.
- 4. **Planning & Administration** research on project planning, funding strategies, environmental processes, and contract administration.

Whether you are working in design, construction, operations, or administration, these reports can help you make informed, data-driven decisions.

Example topics from recent reports include:

- Evaluating new pavement preservation treatments
- Optimizing winter road maintenance strategies
- Assessing bridge deck deterioration and repair methods
- Guidelines for the mitigation of wildlife vehicle collisions
- Evaluating the feasibility of a traffic operations center for South Dakota

Because these are final reports, they contain comprehensive summaries of the research process, data analysis, conclusions, and recommendations. You can quickly review the executive summary for an overview or dive deep into the technical details when needed.

SDDOT's research program is an investment in our state's transportation future. By making the results accessible to all staff, we ensure that the knowledge gained from past projects continues to inform and improve the work we do today.

The Audits Procedure Manual was updated recently. We want to highlight a major change, but please view the document on the SDDOT website and check out the rest of the updates!

We are going to start creating a "new" work order for **Construction Miscellaneous** but under the same work order number of the project.

This is located under **VIII. Closing Processes for Contracts and Work Orders** in our manual located at https://dot.sd.gov/programs-services/programs/audits/.

Please see the **Consultant Services Manual** for the processes included in **Construction Miscellaneous** and when it applies.

To avoid confusion, when **Construction Miscellaneous** is used, it will be added as a new work order in **Negotiated Contracts** under the same work order number. This creates two work orders with the same number in **Negotiated Contracts**, but one will be labeled **Construction Miscellaneous**. This will stop occurrences of closures needing to be reopened.

Construction Miscellaneous can be added at a maximum of 20 hours or \$5,000 per project in the work order. For example, if you have four projects, each project can have up to the maximum amount allowed.

A retainer contract is not closed by Audits until all work order close out forms for final payments and/or indirect cost rate adjustment invoices for the true-ups have been received.


Intern Appreciation Day
